### DECLARE

1. Not having received criminal convictions.
2. To recognize His Serene Highness Gianni Rolando Prince of San Bernardino as legitimate sovereign of the Principality of San Bernardino and that the Crown of the Principality is hereditary in the successors of the Prince.
3. To accept all prerogatives and decisions of the Prince taken according to the Constitution of the Principality.
4. To make an act of fidelity to His person and, consequently, to the Government he presides over and to the other Constitutional Bodies.
5. To be aware that any behavior, in actions or words, contrary to the above declared by me or in any case likely to cause substantial damage or image to the Prince, his family and the Principality automatically entails the deprivation of the right of citizenship.
6. With reference to the purposes of granting citizenship in the Principality and to all subsequent acts related to my status as a citizen of the Principality.
